NOTIFICATION

The 31st August, 2021

No. GLR(RC)7/2020/18.- In exercise of the powers conferred by Section 3(1) read with Section 5 of the Assam Tea Plantations Provident Fund and Pension Fund and Deposit Linked Insurance Fund Scheme Act, 1955, (Assam Act X of 1955), the Governor of Assam is pleased further to amend the Assam Tea Plantations Provident Fund and Pension Fund and Deposit Linked Insurance Fund Scheme, 1968, hereinafter referred to as the principal Scheme, namely:-

Short title, application and commencement

- (1) This Scheme may be called the Assam Tea Plantations Provident Fund and Pension Fund and Deposit Linked Insurance Fund (Amendment) Scheme, 2021.
- (2) It shall apply to all Tea Plantations and Tea Factories in Assam as described in the Act.
- (3) It shall come into force on the date of its publication in the Official Gazette.

Amendment of para 25 (a) (a)

- In the principal Scheme, in para 25, in clause (a), in sub clause (a),-
- (a) the word "accounting" shall be inserted between the words "every" and "year";
- (b) the words and figures "within 90 (ninety) days from the date of declaration of the interest by the Board" shall be inserted after the word "year" and before the punctuation mark "."

Amendment 3. of para 46

In the Principal Scheme, in Para 46, after the existing provisions of sub-para (e), a new sub-para (f) shall be inserted as below -

"(f) Fee for default in submission of Forms, Returns and Statements, etc. - Without prejudice to any other provisions in the Act and in the Schemes, where an employer fails to submit any return, forms, statements or any other document required to be submitted under the provisions of the Act and the Schemes within the time prescribed under Para 24 (e), Para 25 (a)(a) or within the time prescribed in any rule framed under the Act and the Schemes or as per any directions issued by the Board, he shall be liable to pay by way of a fee, a sum of Rs. 1000/- (Rupees One Thousand) per day for delay from the due date so as far it relates to submission of Annual Return under Para 25 (a) (a) and a sum of Rs. 500/- (Rupees Five Hundred) per day for delay in submission of other Forms and Returns."
