Viva-Voce for the post of Assistant Fund Control Officer (AFCO)

The Candidates who have been shortlisted for the Stage III (Viva-Voce) process for selection to the post of AFCO in ATEPFO are advised to note the following Instructions and Schedule on the day of Viva-Voce.

Important Instructions:

- Mere short listing for Stage III (Viva-Voce) of selection process shall not automatically make an applicant eligible for recruitment. The Authority reserves the right to cancel the candidature of any candidate as and when any ineligibility condition is detected and any of the particulars declared by any candidate is found to be false at any stage.
- The verification of original documents etc. would be taken up in the examination venue itself. All candidates must bring their ORIGINAL ADMIT CARD of the Written Test held on 8th November 2020 which has been signed by the candidate and the invigilator at the examination venue; a recent passport size photograph; Original Copies of Admit Cards, Pass Certificates and Mark Sheets of HSLC, HS and Degree Examinations; Employment Registration Certificate; Caste/EWS/TGL/PwD Certificates (in case of reserved category candidates) while reporting for Stage III.
- Candidates may note that the Viva-Voce and Document Verification will be taken up in separate sittings and they may, therefore, come prepared to remain in the venue for the whole day.
- No TA/DA, etc will be provided to any candidate for appearing in this test.
